The coaches meeting of Saturday, November 2nd, was again very well done. I am most pleased that the organization of golf coaches in Wisconsin is embracing the game of golf in such a fine manner.

I have a concern however. The concern is an apparent reluctance of a portion of the constituency not to understand the value of "coaching" on the course while young men/women are competing.

I have been an advocate of "coaching" since I began coaching 15 years ago. I would like to share my rationale for continued support of "coaching" during competition.

First and foremost our mission, as educators, is to provide the student/athlete with the best learning experience available. In order to do this, I believe we should be visually present to the student/athlete. Our time with five players on the course proper would naturally be

Second- during the shared time, we, as coaches, should be able to communicate verbally with the player. This communication can be motivational as well as technical support. The coaches I know can all provide the motivational support. The technical support will vary according to the individual. The individual or his school will have the opportunity, in this case, to gain an edge by becoming more technically oriented. After all, isn't this a team competition? I do believe I, as coach, am part of the team.

I know that personally I have become a better coach because I have to go to each site better prepared to provide the team with an edge. The edge is the difference in winning and losing. I also know it is easier to develop the individual as a human being when his mind set is in a winning mode.

Third - We owe, to the parents, a report of the student's/athlete's progress. The fact we can report a posted score is not enough. We, as coaches, should be able to report how the score was derived as we see it. I believe this can be done only by being where the action is.

Fourth - To properly communicate with the player and offer advice for improvement, we would have to site specific areas of progress and areas that need more improvement. I know this can only be done by visually monitoring his/her play on the course.

I realize this is one coach's perspective, but I have been able to monitor results of those who coach and those who "drive the bus." Believe me, the winning teams are "coached."

Rule Changes for 1992

Ball Lost in Immovable Obstruction:

A new rule provides free relief for a ball lost in an immovable obstruction on the course, such as a shed. Previously, a player who could not find his ball in an immovable obstruction was required to proceed under the Rule for a lost ball. The new Rule requires there be reasonable evidence that the ball is indeed lost in the obstruction.

Ball Lying in or Touching Hazard:

The prohibition against touching the ground in a hazard while a player's ball lies in the hazard is slightly liberalized. A revised Exception states there is no penalty if a player touches ground in any hazard or water in a water hazard as a result of or to prevent falling, in removing a moveable obstruction, in measuring or retrieving or lifting a Ball under any Rule, or if he places his clubs in a hazard, provided nothing is done that constitutes testing the condition of the hazard or improves the lie of the ball. A new decision effective January 1, 1992, will make it clear that using a cane or club to prevent falling in entering or leaving a hazard will be permissible under the Exception.

Line of Play, Line of Putt: Prior to January 1, 1992, there had been no definition of the Line of Play or Line of Putt in the Rules of Golf. Both are now included. Since both definitions provide for the

line to end at the hole, Rules 13-2 and 16-1c have been amended. Rule 16-1c is expanded to prohibit the repair of damage to the putting green, other than old hole plugs or ball marks, that might assist the player in his subsequent play of the hole. This change prohibits tapping down spike marks in the vicinity of the hole. Rule 13-2 is expanded to prohibit improving a reasonable extension of the line of play beyond the hole.

Rule 4-4 (Maximum of 14 Clubs):

Amended to prohibit the addition or replacement of a club by borrowing any club selected for play by any other player on the course.

Rule 8 (Advice; Indicating Line of Play):

The note is amended to permit a team captain or coach to give advice to members of a team in a team competition whether or not there is a concurrent individual competition.

Rule 16-1g (The Putting Green; Playing Stroke While Another Ball in Motion):

Amended to state that a player incurs no penalty for playing a stroke while another ball is in motion after a stroke from the putting green provided it was his turn to play.

Rule 20-2b (Dropping and Redropping; Where to Drop):

Amended to provide that when a ball is to be dropped as near as possible to a specific spot, it must be dropped not nearer the hole

than the spot, which shall be estimated if it is not precisely known.

Rule 23-1 (Loose Impediments; Relief): Amended to prohibit removing a loose impediment that might influence the movement of the ball while the ball is in motion.

Rule 24-1 (Moveable Obstruction): Amended to prohibit removing an obstruction that might influence the movement of the ball while the ball is in motion, other than an attended flagstick or equipment of the players.

Rule 25-1a (Casual Water, Ground Under Repair and Certain Damage to the Course; Interference): Amended to state that a player is entitled to relief from casual water, ground under repair, or a hole cast or runway made by a burrowing animal, a reptile or a bird only when the ball lies in or touches such a condition, or the condition is on the course and interferes with the player's stance or the area of his intended swing.

Rule 33-7 (Disqualification Penalty; Committee Discretion): Expanded to state that any penalty less than disqualification shall not be waived or modified.

Rule 34-1b (Claims and Penalties; Stroke Play): Expanded to state that competitors who agree to waive the Rules (Rule 1-3) shall be disqualified even after the competition has closed.

Appendix II Rule 4-1a (General):

Added to provide limited adjustability in the design of putters. Adjustability is limited and adjustment is not allowed during a stipulated round.

Appendix II Rule 4-1c (Grip):

Amended to provide that if a putter has two grips, both grips must be circular in cross section. However, putters that do not conform with this Rule may continue to be used until December 31, 1992.

Historical Highlights by Gayle Wilfong, Fond du Lac HS

1991 marks the twentieth annual WIAA State Girl's Golf tournament. The first girls' golf tournament was held at Winagamie Golf Course in 1972. The individual championship was won by Mary Hafeman of West Bend East. Madison West won the first of five consecutive WIAA State Team Championships. The city of Madison dominated the championship series until 1978 when Fond du Lac and Appleton West tied for first place. Fond du Lac won a playoff 22-23. Teams from Madison Memorial have appeared in 16 of the 20 state tournaments played and have had five individual State Champions: Chris Tallard in 1974, Chris Regenberg in 1976 and 1977, and Sherri Steinhauer in 1979 and 1980. Mary Beth Nienhaus from Appleton West has coached four State Championship teams and four Individual State Champions. Both Fond du Lac and Madison Memorial have been participants in 18 of the 20 tournaments with either a team or individual golfer.

Twelve teams participated in the first two championships at Winagamie. In 1974, an eight team field moved to Camelot where Cindy Duff from Green Bay Southwest recorded a hole-in-one. In 1975, the tournament was expanded to a two day, thirty-six hole event. 1976 saw a combined girls' and boys' tournament at Lawsonia Links. It was there that Barb Aliota from Brookfield Central scored the second tournament hole-in-one. The tournament format changed again in 1986, when the boys were no longer a part of the tournament and in 1987 when the field was expanded to 10 teams.

The weather has always had an interesting effect on the tournament. In 1974, snow had to be removed from the greens at Camelot and the play-off for individual places was concluded in the dark using headlights from the parking lot. The most snow ever recorded during tournament play was in 1990 when six inches of the white stuff greeted golfers attempting to play a practice round at Lake Arrowhead. Rule modifications, a shotgun start and "casual snow", were played.

Fall Meeting
November 2, 1991
Appleton WI (Winagamie Golf Course)

Members present: Mary Beth Nienhaus, Lee Kaczmarek, Joe Harlow, Dennis Tiziani, Tony Coleman, Tom Conrad, Ernie Nieman, Chuck Menzel.

The meeting was called to order by Mary Beth Nienhaus at 9:12 am.

Secretary's Report: Minutes from the spring meeting were distributed, reviewed and discussed. Motion was made by Harlow, seconded by Menzel that the minutes be approved as written. MOTION CARRIED.

Treasurer's Report: Treasurer's report was distributed, reviewed, and discussed. It was noted that the GMO ticket sale was the largest fund raiser. Most tickets were sold away from the Milwaukee area. Motion made by Harlow, seconded by Nieman that the treasurer's report be approved. MOTION CARRIED.

President's Report: Mary Beth Nienhaus reported that the following people had resigned from the board: Len Friede, John Janty, Joe Bird, and Dan Chubrillo. Replacements for these positions were discussed with letters being sent to those considered for these positions.

Mary Beth stated that a letter of thanks was sent Tom Strong and the GMO for again donating 200 tickets to the WWSGCA.

A letter was also sent to Bob Hornung of Hornung Golf Supply thanking him for the donation of bag tags for the membership.

A letter from Gregg Shimanski was distributed. The letter was a thank you to the association for his acceptance into the WWSGCA Hall of Fame.

The "Coach Approach" is now being done by Lee Kaczmarek. Expenses incurred in the publishing of the paper were discussed. No change will be made in publishing procedure.

Lee Kaczmarek and Joe Harlow explained a redistricting plan of the WWSGCA involving districts, with a set number of conferences being assigned to a given district. Discussion was held. Nieman moved, seconded by Harlow to divide the state into 12 districts with approximately 3 or 4 conferences assigned to each district and that each conference have a liaison to the district representative in order to distribute information from the WWSGCA. MOTION CARRIED.

Replacements for 1st and 2nd vice-presidents and district representatives were discussed. Mary Beth will contact people on the WWSGCA board to fill these positions.

WSGA Report: Gene Haas not present.

PGA Report- Tony Coleman: Discussion was held about holding the spring clinic in association with the PGA Expo. Tony was receptive to the idea and stated that rooms could be found to accommodate the clinic. Time frame possibilities were discussed. Possible date would be February 29. Tony will get back to the board with recommendations. Tony and Kaz will also get together to coordinate clinic activities. Tony gave a report on the PGA Junior Tour. 5 tournaments were held and all were sold out. 10 meets are to be held next year. There is a possibility that a Junior Tour Association may be formed. Details will follow. Tony distributed FIRST SWING LEADER GUIDE books. Hopefully this will be distributed to all WWSGCA district representatives who will in turn make it as well as order blanks available to conference representatives. Tony also brought up the fact that the PGA has taken a stand on the issue of coaches playing during meets. The PGA would like to see coaches out on the course "coaching" during meets. Tony and Dennis Tiziani will submit articles to the Coach Approach on this topic. Tom Conrad suggested that FIRST SWING materials be included in coaches packet of materials at the spring clinic.

Golf Foundation - Dennis Tiziani: Dennis related that the foundation was having some problems at the present time, but despite these problems the foundation was on the right track and will proceed as planned.

Information on the University Ridges Course and golf learning center was presented with Dennis stating that instead of one learning center, a possibility of a few learning centers around the state was being discussed. Dennis also related the progress of the UW Men's and Women's golf teams and what to look for in future years.

Rules - Chuck Menzel: A copy of the 1992 rule changes were passed out. Rule interpretations will continue in the Coach Approach.

Membership: Joe Harlow reported just over 100 memberships have been received at this time. Those membership applications with comments were read by all board members in attendance.

The Rules Corner

Q A player, unable to find his ball, puts another ball into play. He discovers that his original ball is in the hole. What is the ruling?

A The score with the original ball counts. The play of the hole was completed when the player holed the original ball.

Q An opponent or a fellow-competitor purposely steps on the player's line of putt with the intention either of improving (ie. by pressing down a raised tuft of grass) or of damaging (ie. by making spike marks). What is the ruling?

A In either case, the opponent or fellow competitor was in breach of Rule 1-2. The penalty is loss of the hole in match play or two strokes in stroke play, unless the Committee

decides to impose a penalty of disqualification.

Q When marking the position of a ball, must the ball marker be placed in behind the ball, or may it be placed to the side or in front of the ball?

A There is no restriction. However, if a player positions his ball-marker in front of the ball on the putting green and in the process does something to the green that might influence the movement of the ball (is. pressing down a tuft of grass) he is in breach of Rule 1-2. Placing a ball-marker in front of the ball is not recommended but it is not in breach of Rule 16-1a because this Rule permits touching the line of putt in lifting a ball, and marking the position of the ball is

part of the lifting process.

Q Player "A" played a stroke in a bunker and failed to get the ball out. He then swung his club into the sand, but his action did not affect his new lie in the bunker. However, since "A" had to play another stroke in the bunker, was he in breach of Rule 13-4 (Ball Lying in or Touching Hazard)?

A YES!! None of the exceptions in Rule 13-4 apply to "A's" action.

Q Individual and team competitions are being played concurrently in stroke play. A competitor is given advice by a teammate who is playing in another group. What is the ruling?

A The teammate would be penalized two strokes. (Decision 8-1/22)

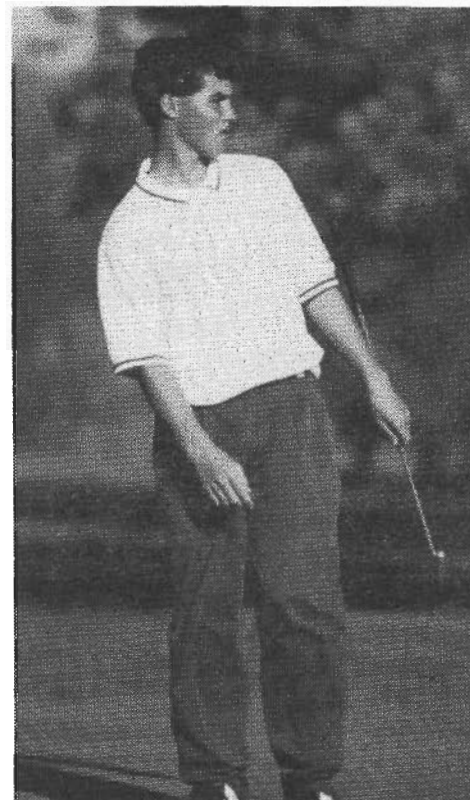
