Clinic proves to be valuable experience for 70 plus coaches in attendance

Over 70 golf coaches from throughout the state met in Madison, Friday, February 24, for the First Annual Wisconsin High School Golf Coaches Association Spring Clinic.

After coffee and rolls, participants attended four sessions designed to prepare them for the upcoming golf season.

Representing the Wisconsin State Golf Association, Gene Haas presented a refresher course on the rules of the game. Complete with visuals, Haas covered a great deal of material in his allotted 45 minutes. Haas covered a variety of situations and fielded questions from those attending.

Don Voeller, former golf coach at UW-Whitewater, presented his thoughts on the state university/college and your players. After

stressing the impact that high school coaches can have on their golfers, Voeller, drawing on his experience of 15 years as a university coach, attempted to outline some of the "pitfalls" coaches can help their golfers prepare to meet upon entering college and further competitive golf.

In his role as a PGA Professional and coach of the University of Wisconsin-Madison golf team, Dennis Tiziani gave coaches an insight into both the UW-Madison golf strength program and an example of typical practice sessions used with his golfers. He also stressed some of the "game essentials" that need to be taught to golfers.


As Vice President and Membership Services Chairperson of the coaches association, as well as varsity girl's golf coach at

Appleton West, Mary Beth Neinhaus provided coaches with an overview of what the association has done so far. She also spent time elaborating on other services under consideration. Time was also allotted for coaches to suggest and to discuss other items for the board to consider.

WIAA's Frank Mc Cormick took time out from the state wrestling tournament to come and address those in attendance. He told members about the rules video rental plan being put into effect by the WIAA.

WIAA has two videotapes in 1/2 inch VHS format entitled Rules of Golf, the Heart of the Game" and "Golf My Way".


The tapes can be obtained by contacting the WIAA's audio visual department. The cost for using the tapes is \$5 per tape. The tapes will

After an excellent lunch, coaches gathered to view the new video "Nice Shot" by Chuck Hogan of Sports Enhancement Associates. As Mr. Hogan explains in a letter that accompanies the video; "Before you jump in, please spend a few minutes reading this letter. For openers, I urge you to use 'The Creative Source' near the end of the video...and follow the instructions precisely.

The results can be phenomenal. You won't be able to explain it. There will be a change and you won't know how or why it was done because your learning took place at a pre-conscious level and it happened in a fleeting moment. The key is to let go... let it happen... and enjoy the results. It's not unlike looking at a painting or hearing a piece of music and being enriched without knowing why.




I'll take a minute here to explain to you how learning actually occurs in the human system. First there is a stimulus. That is, some information is presented. Your brain immediately scans its existing knowledge stored in memory. When there is a mix or overlap of new information with stored information, a new concept is created. 'The Creative Source' vastly accelerates learning because it bypasses conscious awareness and communicates directly to the pre-conscious. What people call 'weird,' is actually imagination, out-of-the-ordinary, creative, experiential. What seems 'weird' is therefore a boundless learning opportunity. Enjoy it!

We have discovered that your brain learns best when you are (1) relaxed; (2) entertained; and (3) when there is a decided shift from left brain skepticism to right brain creativity. Balata and the cast of characters you'll meet in your Playbook were developed to meet

Gary Wren's Personal Golf Objectives

1. You will set a reasonable schedule of practice and training that you can meet, and then stick to it. There will be emergencies and situations that cause an occasional miss, but be as regular as possible.

2. Be positive about yourself, your game, and what you are doing.

3. Practice with an objective in mind. Since your time is short, make your practice time of high quality. Play each shot as though on the course except for when warming up. Fewer balls; more perfect shots.

4. When playing even in a casual round, take enough time to execute properly. As long as you are taking the time to play, even for fun, do it right.

5. Winners are not always those who have finished first. A winner is someone who gives the most in preparation to reach his potential and makes every effort to perform at his highest level. There will be times when that is accomplished and you still aren't victorious, but you are a winner.

6. No opponent is deserving of either lack of respect or an attitude of awe. In any reasonable match of talent either competitor can win on a given day.

7. You may not have the best talent in a match. But tough competitors often overcome superior talent. Patience and perseverance will pay off in golf.

8. Be consistent in your performance, focusing on the task at hand for the full time you are playing. Don't ease up when ahead or quit when you're behind. You never know what might happen to

you or your opponent, so keep your focus.

9. Self control is a trait that you should strive to achieve. Lack of self control is harmful to performance as well as to individual growth as a person. It reveals itself in club throwing, displays of temper, offensive language, verbal abuse of officials, complaining or discrediting the event or facility, etc.

10. Keep your body in good physical shape by observing the following suggestions:

a. Eat three balanced meals daily avoiding as much as possible fried foods, rich desserts, too much protein, fat, and salt. Eat more fresh fruits, vegetables, cereals and grains.

b. Get 7-8 hours of sleep a night.

c. Limit or abstain from the use of chemicals including alcohol. Don't train faithfully and then waste yourself in one night.

d. Include a mixture of flexibility, cardio-vascular and strength work in your physical training program.

11. Be committed but keep it in perspective. There are other more important things in life. Putting it in perspective will help you as a competitor to realize you don't have to win, only do your best.

12. Enjoy what you are doing. If it isn't rewarding or enjoyable, then reevaluate your program and make it so!

This is the second round of results from the state high school golf coaches survey which was completed last spring. As you might recall, some of the survey results were published in the December issue of The Coach Approach. As you study the responses to the various questions, keep in mind that 162 high school coaches' views are represented (77 from WIAA class A schools, 50 at class B, 15 from class C schools, and 20 have WISAA affiliation). The respondents coached girl's teams, boy's teams or both girl's and boy's teams.

Marian begins men's golf

Dear Mr. Shimanski,

Yesterday, our College Athletic Director gave me the December 1988 edition of your newsletter. I read it and found it to be a very informative document. I would like to provide you with some background on myself and why I am contacting you.

Permit me to introduce myself as William Rhudy. I am Vice President for Student Affairs and Dean of Students at Marian College in Fond du Lac. This is my second year at Marian. Prior to that I was at a college in the state of Iowa, and one of the roles I served for six years was as varsity golf coach.

Here at Marian we do not presently have a golf program; however, we once did and I am told it was a strong force in the District and in the midwest. However, next year we will again have golf as a varsity sport for men. We have received inquiries from current students and prospective high school seniors. Subsequently, we are going to reinstate it and I am going to serve as coach. While our conference prohibits the term scholarship, we, as do other schools, offer "merit grants" for athletes. We will have a merit grant budget for golf so I will be able to offer financial incentives to promising players

While I am recruiting from other surrounding states, my first hope is to bring players to Marian from the state of Wisconsin. State residents have many more financial aid opportunities available versus out of state residents.

While my objective will be to build as strong a team as possible, I am also realistic that it will take some time to progress. I am very willing to meet and work with high school students of any caliber as long as they are committed to a varsity program. I am now first and foremost interested in creating and building a team.

For your use rules test -part 2

This is the second part of the rules test complied by the Rules Committee of the Wisconsin State High School Golf Coaches Association. Again this test can be used to see that your players have an understanding of the rules of the game.

It should also be noted that there were two "typo's" in the answer section to part 1. The answer to question number 3 should have included G as an answer. Question number 11 should have been C, not A.

Rules test #2

1. During a tournament one of your opponents wraps his **putter** grip with gauze or tape. What is the penalty?

- A. None
- B. One stroke
- C. Two strokes

2. I have a booklet giving the exact distances from various points to the green for each hole on a golf course. Is there a penalty for its use?

- A. Yes
- B. No

3. During a tournament a player on another team is faced with a blind shot to the green. He places a club at the top of the hill in line with his ball and the pin and then plays his shot. What is the penalty?

- A. None
- B. One stroke
- C. Two strokes
- D. Stroke and distance

4. Your ball lies on a cart path. You determine your nearest point of relief for lie and stance, mark the spot and then:

- A. Drop within one club length
- B. Drop within two club lengths

5. Your ball lands in a bunker that is filled with water from an overnight

rain. Your option is:

- A. Free drop under the casual water rule
- B. Play your shot from the bunker
- C. Drop out of the bunker with a one stroke penalty
- D. Drop out of the bunker with a two stroke penalty
- E. Both B and C

6. While playing hole number 12, I damage my golf ball. On that same hole, before playing my next shot from the rough, may I replace the ball?
